ORDER

This is an application under Section 438 of Cr.P.C. for releasing the applicant on anticipatory bail in Crime No.938/2022 registered with Goregoan Police Station for the offence punishable under Section 420, 465, 468, 471 of I.P.C.

2. Perused the application and say of Investigation Officer.

- 3. Heard Adv. Mr. Siraj Ghiwala and APP Mr. Shailesh Pachapohar for the State.
- I have carefully gone through the FIR. It revealed that the informant and the applicant were friends and there is some transaction between them. Having gone through the documents placed on record, it seems that the applicant purchased vehicle Ertiga by way of loan through Mahindra Finance. Thus, it appears to be dispute of civil nature. The custodial interrogation of the applicant is not required. In such circumstances, the applicant is entitled for anticipatory bail in the event of his arrest. I, therefore, pass the following order:-

ORDER

- 1. The applicant- Guddu Ali S/o. Shahadat Ali be released on anticipatory bail on executing personal bond in the sum of Rs. 20,000/- (Twenty Thousand Rupees Only) with one or two sureties in the like amount, in the event of his arrest in Crime No.938/2022 registered with Goregaon Police Station for the offence punishable under Sections 420, 465, 468 and 471 of I.P.C., on the following conditions:
- (i) He shall attend police station twice a month i.e. on 5th and 20th day of month in between 11.00 a.m. to 12 noon, till filing of charge-sheet.
- (ii) He shall not tamper with the prosecution evidence.
- (ii) He shall furnish his permanent residential address proof with Investigation Officer.
- 2. The Investigation Officer is directed to acknowledge the presence of the applicant.
- 3. Inform the concerned Police Station, accordingly.

4. Anticipatory Bail Application No. 1919/2022 stands disposed of, accordingly.
