# <u>ORDER</u>

1. This is an application under Section 438 of Code of Criminal Procedure (hereinafter referred as "Cr. P. C.") for anticipatory bail on apprehension of his arrest in connection with C.R.No.2296 of 2022

registered at Police Station, Sakinaka for the offences under Sections 341, 452 of the Indian Penal Code (hereinafter referred as 'IPC'). on the report of informant Abdul Majid Shaikh.

- 2. Perused the application and say. Perused the investigation papers. Heard Ld.Advocate Shri A.K. Upadhyay for applicant-accused and Ld.Addl. PP Shri Ambekar for the State.
- 3. In short, it is alleged by the informant that on 27.11.2022 applicant, sister of informant alongwith two unknown ladies forcefully entered in the shop of informant and gave threat to the workmen and force to close the shop. The offence under section 341 of IPC is bailable. There is no such allegation for offence under section 452 of IPC which required custodial interrogation. Hence, I passed the following order.

## **ORDER**

- 1. Anticipatory Bail Application No.1943 of 2022 is hereby allowed.
- 2. In the event of arrest, applicant-accused **Mrs. Nusrat Mohd. Kalam Shaikh**, in connection with C. R. No.2296 of 2022, registered with Police Station, Sakinaka, for the offences punishable under Sections 341, 452 of IPC, he be released on executing P. R. Bond of Rs.15,000/- (Rs. Fifteen Thousand only) and in the like amount with one surety.
- 3. Applicant-accused **Mrs. Nusrat Mohd. Kalam Shaikh** shall report to the police station, Sakinaka on 21.12.2022 in

between 11.00 a.m. to 1.00 noon and shall co-operate to the Investigating officer as and when required for the purpose of investigation.

- 4. Applicant-accused **Mrs. Nusrat Mohd. Kalam Shaikh** shall not tamper the evidence.
- 5. Anticipatory Bail Application No.1943 of 2022 stands disposed off accordingly.
