ORDER

This is an application for anticipatory bail under Section 438 of Cr.P.C. in relation with Crime No.793/2022 registered with Bangur Nagar Police Station for the offence under Sections 354, 509, 323, 504 and 506 of I.P.C.

- 2. Perused the application and say of Investigation Officer.
- 3. The informant appeared as intervenor through Adv. Mr. Ashish Singh.
- 4. Heard all the parties. The intervenor filed affidavit that she lodged the report under misunderstanding and misconception and now she has no objection to enlarge the applicant on anticipatory bail.
- 5. Keeping in mind the amicable settlement between the parties, I have considered the submissions of the learned advocate. It revealed from the record that the applicant and informant are in live in relationship. Considering the facts and circumstances, I think it would be proper to enlarge the applicant on anticipatory bail. I, therefore, pass the following order:-

ORDER

- 1. The applicant-Imtiyaz Moinuddin Shaikh be released on anticipatory bail on executing personal bond in the sum of Rs. 15,000/- (Fifteen Thousand Rupees Only) with a surety in the like amount, in the event of his arrest in Crime No.793/2022 registered with Bangur Nagar Police Station for the offence punishable under Sections 354, 509, 323, 504 and 506 of I.P.C., on the following conditions:
- (i) He shall attend police station as and when called by the Investigation Officer, till filing of charge-sheet.
- (ii) He shall place on record his recent residential address proof and contact details.
- 2. Inform the concerned Police Station, accordingly.

3. Anticipatory Bail Application No. 1866/2022 stands disposed of, accordingly.
