**ORAL ORDER**

Vide order dated 20/12/2022 ad-interim anticipatory bail was granted to the applicant as he was apprehending arrest in a

complaint filed by one Subhro Banerjee at RAK Marg Police Station under the provisions of POCSO Act. However, no FIR was registered. Even then due to the apprehension, interim protection was granted to the applicant.

2. The prosecution submitted that till date no FIR is registered against this applicant. PI Patil of RAK Marg Police Station in person stated the same and vide Exh.2 also same is reported.

3. Heard learned Advocate for the applicant and learned SPP for State.

4. It was confirmed by the applicant himself that, no FIR is registered against him till date. There cannot be a blanket order for unlimited period. Therefore, the ad-interim order dated 20/12/2022 deserves to be vacated. Hence, I proceed to pass the following order: -

1. Ad-interim order dated 20/12/2022 is vacated.
2. Accordingly, Anticipatory Bail Application No.2782 is disposed of.
