# ORDER BELOW EXH. NO.1 (Delivered on 08<sup>th</sup> February, 2022)

- **1.** This is an application filed under Section 438 of Criminal Procedure Code for grant of pre-arrest bail.
- **2.** Read the application and gone through the documents filed alongwith it. Perused the say filed by the respondent vide <u>Exh.5.</u> Heard Ld. Advocate for applicant and Ld. A.P.P. for respondent.
- **3.** Upon hearing and going through the material placed on record, what can be gathered is that, on a written complaint of one

Parikshit Bhau Nikam an inquiry is initiated by the respondent and the applicants were called on 07.01.2022. However, it seems that, the applicants did not appear before the respondent. Perusal of the say reflects that, Crime is not yet registered. It seems that there was some money transactions between the parties, of which certain Cheques were issued, which came to be dishonoured and complainant felt cheated. This Court finds that, as the Crime is not yet registered, therefore by giving certain directions, the application can be disposed off. Hence, the order.

#### ORDER

- **1.** Criminal Bail Application No.145/2022 is disposed off as follows:-
- (a) In the event of registration of Crime on the written complaint Parikshit Bhau Nikam with the respondent, then 72 hours prior written notice be given to the applicants before their arrest.
- **2.** Applicants to appear before the Police Officer of respondent/Police station whose is inquiring the matter on 14<sup>th</sup> February, 2022 between 11.00 a.m. to 01.00 p.m. and co-operate the said Officer in the inquiry.
- **3.** Informed the respondent accordingly.
- **4.** In the above terms, Criminal Bail Application No.145/2022 stands disposed off accordingly.
